Information on the Regulation (EC) No 1907/2006 (REACH) and Regulation (EU) 2019/1021 (POP)

Our company takes the obligations regarding product compliance and the requirements according to Regulation (EC) No 1907/2006 and Regulation (EU) 2019/1021 very seriously. The main focus lies on the marketability of our products. In this process we are also supported by our external consulting company, asseso AG.

As manufacturer and trader within the supply chain, we are well aware of our duties and responsibilities according to the REACH Regulation and the POP Regulation and legal requirements are always considered and fulfilled.

GUNOLD GmbH is under no obligations to register substances according to REACH since this is the responsibility of suppliers, respectively upstream actors. With regard to products from non-EU countries, we state that an exposure of these substances has not been intended and therefore an obligation to register has not been indicated so far. Compliance and availability of the products according to the REACH-Regulation are therefore guaranteed. Correspondent Safety Data Sheets for mixtures and Information Sheets about products respectively are available and will be sent to you upon request at any time.

According to Article 33 of the Regulation (EC) No 1907/2006 (REACH), we can state that, based on the current information provided by the suppliers, there is no notification requirement for substances listed in Annex XIV or the so-called candidate list. The candidate list is dynamically expanding, so we can only refer to the currently listed substances.

In addition, our company performs supplier surveys periodically ensuring that we will be informed in due time about products which contain substances that have been added to ANNEX XIV of the REACH Regulation or the so-called candidate list. This guarantees that our customers will be notified about newly added substances of very high concern without any delay.

Furthermore, we can confirm that the requirements relevant for our products, which result from Annex XVII of Regulation (EC) No. 1907/2006 (REACH) and from Regulation (EU) 2019/1021 (POP), are met. We comply with the legally prescribed substance prohibitions/restrictions.
